 - Members involved are to have obtained prohibited persons clearance.
 - Fundraising activities are to be in compliance with requirements of Service Standard 1.1.16 Fundraising Activities (Provision of Goods and Services).
 - The consumption of alcohol or any prohibited substance is not permitted whilst members are participating in the activity and or dressed in Rural Fire Service uniform.
 - No children on RFS vehicles unless directly supervised by their parent/guardian
 - The Captain or delegate is to supervise the actions of persons attending and to ensure all conditions listed above are met.
 - Any approach to media organisations is to be approved by the FCO or Duty FCO.
 - Safe food handling guidelines to be adhered to and supervision to be provided by suitably qualified personnel.
 - Live Fire Activity (conducted as per Live Fire SOP 6.1.5-1 to 6.1.5-6)
